## BOOK REVIEW

**IMPERIALISM AND INTERNATIONAL LAW: THE CASE OF THE  
NORTHERN MALAY STATES IN THE 19TH CENTURY**

**Piracy, Paramountcy And Protectorates\***

It is not often that the unprecedented expansion of European imperialism in Asia during the nineteenth century receives more than a cursory glance from students of disciplines other than history. The irrepressible drive of the great powers in extending their imperial frontiers from India on the one hand into Burma and the Malay Peninsula and from Cochin China on the other into Vietnam and Laos resulted in a bitter contest for power and influence that threatened the very basis of European diplomacy. This imperial rivalry reached its peak with the entry of Germany and Russia towards the last quarter of the century and is generally regarded as a contributory factor to the outbreak of the First World War. The historical significance of this process of imperial expansion has been studied in extraordinary detail and at great length and it would be no exaggeration to say that the state of scholarship in this particular aspect of the history of both Europe and Asia had reached its nadir by the beginning of the decade of the 1970s. Apart from a fine crop of thoroughly researched and penetrating case studies of the expansion of European control over the Indian frontier regions, Burma, the Malay Peninsula and Indo-China, there are innumerable articles in learned journals by some of the most distinguished scholars. This impressive advance in our knowledge of the period was largely made possible by the opening-up of the official archives, particularly in Britain, France and Germany, during the 1950s coupled with the accessibility to the researcher of the private papers of the more important statesmen and diplomats of the time. One would, therefore, be forgiven for being some-
