The Malaysian position is also considered in detail, in particular, the extent to which the Contracts Act (esp. the 22 sections on suretyship) alters or modifies the common law position. The book is very much concerned with the practical realities of the law of guarantees. In fact, the most salient feature in suretyship law is the fact that the standard form guarantee has generally been allowed to prevail. Recent developments are also examined closely.
